**SECTION GC 1.0 - INTERPRETATION**

**GC 1.04 Ontario Provincial Standards**

Subsection GC 1.04 of OPSS 100 is amended by the addition of the following paragraph:

~~.078~~ The municipal-oriented Ontario Provincial Standard specifications applicable to the tender items for this Contract are detailed in the following table. In the case where a provincial-oriented specification(s) also applies to a tender item listed in the table, the Material and work covered by each specification will be specified in the Contract Documents.

Fill in table with tender items and OPSS.MUNI specifications listed as per the following guidelines:

1. Some MTO Contracts may have items that are governed by municipal-oriented OPS specifications. For example, traffic signals and lighting systems at the end of freeway ramps may be governed by municipal-oriented OPS material specifications when the municipality agrees to be responsible for maintenance after the warranty period. Common and provincial-oriented specifications are listed in the schedule of the tender for MTO Contracts, but municipal-oriented OPS specifications are not listed there.

For each item covered in whole or in part by a municipal-oriented OPS specification(s), fill in the table as specified below:

Column 1: The item number of the tender item as designated in the tender e.g., 68.

Column 2: The tender item title as it appears against the tender item number in the Tender e.g., Concrete Poles.

Column 3: The OPSS.MUNI construction specification number and date that covers the work for the tender item e.g., 904 dated January 2012. Enter "Not Applicable" if the tender item is governed by a common or provincial-oriented specification and there is a municipal-oriented material specification that applies.

Column 4: The number and date of all municipal-oriented construction and material specifications that are referenced by the construction specification. Enter "Not Applicable" if there are no referenced municipal-oriented specifications. Do not list the common and provincial-oriented OPS specifications since these are in the list of referenced specifications in the tender.

2. When the work or material for a single tender item is covered by a municipal-oriented and a provincial-oriented specification, the quantity sheets in the Contract Drawings, a non-standard Special Provision or a modified version of this Special Provision may be used to detail the locations of the parts of the material and work that are covered by each specification.
